# Disposal of unapproved past membership minutes

President Biebuyck asked for a Motion to approve the past Special Membership Minutes of May 26, 2020. Motion made by Eric Brown, Seconded by Morris Bencini, all in favor.

### **President's Report**

President Biebuyck began the meeting by addressing a question from an owner regarding why the Owners were not asked to approve the Budget. President Biebuyck explained that in the past, prior to Castle Group, owners were required to approve the Budget because the Reserves were not fully funded. They are fully funded now and the Budget is only approved by the Board in accordance with the Declaration of Condominium. Owner participation is aavailable and encouraged through attendance at Finance Committee monthly meetings and Budget Workshops, which are noticed and open to all Owners.

Another question was raised about the results of the survey on owner preferences for use of the land sale proceeds, which should be summarized by Coby Gaulien, Jeff Winsler and Kyle Krezminski, the Webmaster. There was mention that the Minutes of the June meeting of the Strategic Planning Committee included a summary. The Survey was intended to provide an indication of general preferences, and several potential projects likely would constitute a material change requiring 75% approval of owners.

Results of any surplus to be rolled over to next year's operating Budget for tax purposes: 71 votes to approve and zero to disapprove.

President Biebuyck asked for a Motion to adjourn, made by Morris Bencini and Seconded by Eric Brown, all in favor, Motion carried.
